1. Opening of the meeting

The 22nd Annual Commission Meeting was convened virtually and in-person at the Swakopmund Sands Hotel in Swakopmund, Namibia from 26th to 27th November 2025. The Chairperson, Mr. Joji MORISHITA (Japan), welcomed delegates and observers to the meeting.

2. Appointment of Rapporteur

The Secretariat was appointed as the rapporteur for the meeting.

3. Adoption of Agenda and Meeting Arrangements

The Commission adopted the agenda (<u>DOC/COM/01/2025</u>) after Agenda Item 14 was removed (Election of Chair and Vice Chair).

The Commission is requested to note the challenge at the start of this Annual SEAFO Hybrid Meetings where, unlike Contracting Parties who may join hybrid sessions virtually or in person, SEAFO Secretariat staff are required to attend all Annual Meetings (SC, CC, SCAF, and Commission) physically.

4. Introduction and Admission of Observers

Observers present were:

- Mr. Jonathon BARRINGTON the Executive Secretary of ACAP.
- Ms. Eszter Hidas: Manager/Technical Advisor Common Oceans Program, Deep-Sea Fisheries Project (FAO), General Fisheries Commission for the Mediterranean of the FAO.
- Ms. Merete Tandstad: Manager of the EAF Nansen Program.

The Commission admitted and welcomed the observers at the meeting. The observers introduced themselves.

5. Opening Statements by Contracting Parties and Observers

Five Contracting Parties were represented at the meeting. Angola was not represented. The list of participants is in <u>Appendix II</u>. Contracting Parties introduced their delegations with short opening statements. The full opening statements received are available in <u>Appendix III</u>.

6. Status of the Convention in Respect for Membership

The ES informed the meeting that no new notification for accession to the Convention was received since the last Commission meeting, by the United Nations Food and Agriculture Organization (FAO).

7. Report of the 2025 Scientific Committee (SC) Meeting

The Chairperson of the 21st Scientific Committee, Ms. Zimasa JIKA (South Africa), presented the 2025 SC meeting report (<u>DOC/COM/03/2025</u>) to the Commission for adoption.

The Commission noted that twelve Scientific Committee members from four Contracting Parties attended the Scientific Committee meeting. No scientific members from the Republic of Korea and Angola attended the meeting.

Each agenda item was presented by SC Chair and opened for questions/comments. Focus was on items requiring Commission action or advice.

SC 7.1 Historical Catches from EEZs

The Commission noted completion of work by SC with no contracting party comments required.

SC 7.2 CPUE Standardization

The Commission noted the ongoing work.

SC 7.3 Standardized SEAFO Maps

Mr. Maletzky committed to fast-tracking the process targeting 2026 completion.

The Commission noted this commitment.

SC 7.4 VME Indicator Species and EAF Nansen surveys

Namibia emphasized the importance of conducting surveys, particularly given BBNJ agreement requirements. The Commission noted the Dr. Fridjtof Nansen unavailability in 2026 and welcomed a possible opportunity for a survey in the SEAFO CA during 2027.

The SC <u>recommends</u> that the Commission keep working with the EAF Nansen Programme.

ACTION: The Commission adopted the recommendation.

SC 7.5 Conservation Measure CM25-12

The Commission observed that overall intercessional discussion arrangements are in place with clear timeline (comments due April 13, 2026, virtual meeting May 13, 2026) and noted support from contracting parties.

SC 7.6 Alignment of Observer Data Form and Captain Logbooks for Long Lines

The Commission noted completion of work by SC with no contracting party comments required.

SC 7.7 VME Bycatch Summary Table Update

The Commission noted completion of work by SC with no contracting party comments required.

SC 7.8 VME Bycatch Hotspot Maps in Stock Status Reports

The Commission noted completion of work by SC with no contracting party comments required.

SC 7.9 Confidence Intervals for Orange Roughy CPUE

The Commission noted completion of work by SC with no contracting party comments required.

SC 7.10 HCR Review (Harvest Control Rule)

The Commission noted concerns expressed by Namibia and South Africa about virtual meeting limitations, recognized SC Chair's explanation of challenges, but could not agree on holding physical meetings annually. Nonetheless the Commission supported the Scientific Committee to continue this important work.

SC 7.11 Patagonian Toothfish Tagging Protocol

All contracting parties recognized the importance of the tagging protocol issue and agreed to continue discussions at the next SC meeting. The Commission expressed support for the SC's approach to analyzing current recapture statistics before determining any increase in tagging rates.

SC 8 Report by the Executive Secretary presenting landing tables updated to the end of August 2025

All contracting parties shared the SC's concern about high *macrouid* bycatch and supported the suggested action to explore possible measures to reduce or mitigate it. The SC Chair clarified that exploring mitigation measures would be discussed at the next SC meeting in 2026. The Commission expressed support for this action.

SC 9 Review spatial and temporal distribution of fishing activity and biological data

The Commission noted the presentation without any questions or comments from contracting parties.

SC 10 Review spatial distribution of reported catches of benthic organisms (corals, sponges etc.)

The Commission noted that no VME encounters (as per Article 8 of CM 30/15) have been recorded to date in the SEAFO Convention Area.

SC 11 Review Stock Status Reports

The Commission noted this was not a stock assessment year, as TACs were already set for 2025-2026. Major stock status and assessment updates will be conducted at the inperson meeting in 2026.

The updated stock status reports serve as repositories for current information and are published on the SEAFO website and shared with FAO's FIRMS program.

SC 12 Review research activities in the SEAFO CA from October 2024 to date

The Commission noted the presentation without requiring any further discussion or action.

SC 13 Examine, where appropriate, assessments and research done by neighbouring States and other organisations

The Republic of South Africa thanked the DSF project for scientific work in Areas Beyond National Jurisdiction, acknowledging its significant contribution to SEAFO's scientific components and cooperation with the Executive Secretary. Namibia appreciated SEAFO's involvement in the DSF project and requested support for SEAFO scientists to participate in upcoming workshops, particularly February 2026 and August 2026 meetings, to gain knowledge in data-limited assessments.

The Commission noted the collaborative research efforts as valuable for improving regional stock assessment capabilities.

SC 14 Data Requests and Research Proposals

The ES clarified that there is a document (<u>DOC/COM/13/2025</u>) prepared on RFMO protection of commercial confidentiality, which directly relates to the matter of data confidentiality in this agenda point of the SC. The Commission will provide directions to the Scientific Committee on handling confidential information in stock status reports.

Namibia raised concerns that the issue of data confidentiality would be impacted by the BBNJ (Biodiversity Beyond National Jurisdiction) agreement coming into force in January 2026.

The Commission noted the request from Parties to add the BBNJ implementation as a future agenda point for the Commission.

SC 15 Any Other matters

SC 15.1 CORDAP Cartography Project

Japan expressed interest in the CORDAP project while drawing attention of the Commission on possible implications for existing fishing grounds.

The Executive Secretary confirmed the project will provide capacity-building opportunities and communication to contracting parties regarding any activities to happen under this project.

SC 15.2 ACAP Update

Namibia supports the work done by ACAP on the conservation of seabirds and announced plans to accede to the ACAP agreement and host ACAP meetings in May-June 2026. South Africa, as a long-standing ACAP member, supported the work of ACAP. Japan noted that seabird mortality has rarely been observed in the fisheries in SEAFO and requested that this point be taken into consideration when considering amendments to bycatch mitigation measures.

The SC <u>recommends</u> that the Commission keep working with ACAP on seabird bycatch mitigation best practices.

ACTION: The Commission adopted the recommendation.

SC 15.3 FAO Deep Sea Fisheries Project Observer Training

South Africa thanked the DSF project for the upcoming observer training and expressed interest in additional capacity-building opportunities for inspectors.

The SC <u>recommends</u> that the Commission keep working with the FAO DSF Project on various projects.

ACTION: The Commission adopted the recommendation.

<u>ACTION</u>: The Commission adopted the 2025 SC meeting report with appreciation for the chair's first-term leadership and all scientists' contributions.

8. Report on the 2025 Compliance Committee (CC) Meeting

The Chairperson of the Compliance Committee, Mr. Beau Tjizoo (Republic of Namibia), presented the 2025 Compliance Committee Report (DOC/COM/04/2025) to the Commission for adoption.

CC 6 Executive Secretary's Report on Compliance

The Republic of South Africa apologized for late submissions of port inspection reports and committed to timely compliance in the future, while requesting assistance for capacity building. The EU stressed the importance of fulfilling SEAFO obligations and appreciated Namibia's follow up response regarding fishing outside designated areas.

CC 7 Annual Review of the "SEAFO System of Observation, Inspection, Compliance and Enforcement"

Both issues (CM25-12 review and toothfish tagging protocol) were extensively reviewed in the Scientific Committee report with clear next steps proposed by the Scientific Committee. The Commission endorsed the proposal by adopting the SC Report.

CC 8 Consideration of the provisional SEAFO IUU Vessel list for 2026

The CC <u>recommends</u> to the Commission to adopt the SEAFO IUU vessel list for 2026 presented in (<u>DOC/CC/04/2025</u>).

ACTION: The Commission adopted the recommendation.

ACTION: The Commission adopted the 2025 CC meeting report.

9. Report on the 2025 Standing Committee on Administration and Finance (SCAF) Meeting

The Chairperson of SCAF, Mr. Wickness Rooifontein (Republic of South Africa), presented the 2025 SCAF Report (DOC/COM/05/2025) to the Commission for adoption.

SCAF 5 Approval of the 2024 Draft Annual Financial Statement (AFS)

The SCAF <u>recommends</u> the Commission to approve the Audited Annual Financial Statements for 2024.

ACTION: The Commission approved the Audited Annual Financial Statements for 2024.

SCAF 6 Presentation of the Executive Secretary's Report on Administration and Finance

The Chairperson noted this agenda item had an action sentence but recognized the action was only noted by SCAF with no specific request to the Commission.

After discussion among parties (with support from EU, Japan seeking clarification, and Namibia supporting), the Commission concluded that the Commission would ask the Executive Secretary to provide 1-2 page summaries to formally record the "behind-the-scenes activities" engaged by the ES for institutional memory. The Chairperson indicated the Commission could trust the Executive Secretary's good judgment on the specific format of the summaries to create formal documentation that would form part of the organization's positive institutional memory.

SCAF 7 Any other matter

SCAF 7.1 Review of the 2016 Performance Review (PR) report relevant to SCAF

The Commission noted its preference for a well-targeted rather than general PR to ensure tangible value. Namibia requested careful selection of consultant for conducting performance review.

Namibia emphasized that while current salaries are adequate, there's no cap to prevent unsustainable escalation and stressed the need for workload assessment for considering appropriate level of salaries. The EU reinforced that adjustments should follow inflation rates and account for SEAFO's size and two-employee structure. Namibia noted that currently the Executive Secretary performs both ES and data manager functions, but future appointees may not have both capacities.

<u>ACTION</u>: The Commission agreed that ES will prepare ToR and budget for a new Performance Review of SEAFO. Contracting parties will provide input on possible items to be included and amendments in the ToR to ES before the next SCAF meeting.

SCAF 7.2 Review of the RFMO support of developing countries to attend intersessional and annual meetings.

The Commission simply noted the report from SCAF without any specific decisions or actions needed.

SCAF 7.3 Capacity Building for Contracting Member States

The Commission noted the report from SCAF for agenda item 7.3, with the understanding that the Executive Secretary will proceed with the facilitation of capacity building as part of regular duties.

SCAF 8 Approval of the 2026 Budget and 2027 forecast Budget

The SCAF Chairperson presented the provisional budget for 2026 of NAD 3,270,656.99 and the forecast budget for 2027 of NAD 3,390,113.31.

SCAF <u>recommends</u> that the Commission approves the budget.

<u>ACTION</u>: The Commission approved the budget of NAD 3,270,656.99 for 2026 and the forecast budget for 2027 of NAD 3,390,113.31.

SCAF 9 Contracting Party Contributions

SCAF <u>recommends</u> that the Commission approves the Contributions by Parties (DOC/SCAF/08/2025 (25 Nov 2025)).

ACTION: The Commission approved the Contributions by Parties for 2026.

ACTION: The Commission adopted the 2025 SCAF meeting report.

10. Report on meetings attended by the Secretariat

The ES submitted a document (<u>DOC/COM/06/2025</u>) to the Commission in which a synthesis of the meetings she attended since November 2024 was presented.

The Commission took note of the report with appreciation to the ES and encouraged the participation of the ES in relevant meetings and to network with other RFMOs and projects.

11. Reports of SEAFO Representatives at meetings of other Intergovernmental Organisations

The Commission noted the reports submitted by the CPs as Observers to other intergovernmental organisations and thanked them for representing SEAFO and providing necessary feedback relevant to SEAFO (DOC/COM/08/2025; DOC/COM/10/2025; DOC/COM/11/2025; DOC/COM/11/2025).

12. Nominations of Parties to represent SEAFO at 2026 meetings of other International Organisations

The Commission adopted the following nominees to represent SEAFO as observers at the following meetings, similar to 2025:

CCAMLR – Republic of Korea
ICCAT – Republic of South Africa
NAFO – Japan
NEAFC – EU
SIOFA – Japan

13. Any other matters

13.1. Report on RFMO protection of Commercial Confidentiality

The ES was tasked during the 2024 Commission meeting to investigate how other RFMOs protect their Commercial confidentiality in order for the Commission to give directives to the SC regarding this matter for future application when needed. The ES presented her findings on how other RFMOs deal with this matter (DOC/COM/13/2025).

Specific Recommendations:

The Scientific Committee should submit specific questions to the Commission when uncertain about data confidentiality in stock status reports.

Consider national data policies when developing SEAFO guidelines.

Ensure consistency with other international projects and organizations SEAFO collaborates with.

The discussion emphasized balancing transparency for scientific purposes with protecting commercially sensitive information.

The Commission agreed on a case-by-case approach for handling data requests while working toward longer-term solutions:

Short-term: Continue evaluating specific data requests individually.

Long-term: Develop comprehensive data confidentiality guidelines similar to other RFMOs.

13.2. FAO Deep-Sea Fisheries (DSF) project feedback

Ms. Eszter Hidas, project manager presented an update of the FAO DSF Project (DOC/COM/14/2025).

The Republic of South Africa acknowledged benefits from capacity-building initiatives and asked for additional DSF supported workshops in South Africa and Angola, specifically for inspectors and MCS officials. Early notification of upcoming DSF meetings will be appreciated due to quarterly travel approval cycles.

The DSF Project manager committed to work with SEAFO Secretariat to assess feasibility of additional capacity building requests.

The Commission expressed its appreciation to the DSF project support and thanked the Project for global and regional work. The strong partnership between SEAFO and the project is reaffirmed.

14. Venue and Date of next meetings

The dates for the 2026 Scientific Committee meeting will be 23-27 November 2026 in physical format in Namibia.

The dates for the 2026 Annual Commission meeting (including SCAF and CC) will be 30 November to 3 December 2026 in physical format in Namibia.

Next year's venue remains in Swakopmund, Namibia with no alternative hosting offers received. Consensus was not reached on the Republic of South Africa's proposal for a rotational hosting system. The rotational hosting proposal remains unresolved and may be revisited in future meetings.

15. Adoption of the 2025 Commission report

The Commission adopted the report.

16. Closure of the Meeting

The Chairperson closed the meeting at 15h35 on Thursday 27th November 2025 and he commended the Contracting Parties for their efficient and effective conduct during the meeting. He thanked the Secretariat for the preparations.
